## DEMOGRAPHICS OF LANARK COUNTY

- Population = 65,700
- ✓ 60% of population is over 40 years old
- ✓ 9 Municipalities
- Area = 3,033 square kilometers
- Influenced by next door neighbour trends – Ottawa
- 4 towns and the remainder is rural







#### BACKGROUND

- No previous housing studies
- Manager, 2 caseworkers, 1 clerk
- Busy time introduction of the Housing Service Act, Community Homelessness Prevention Initiative, assumed responsibility for Centralized Wait List from Lanark County Housing Corporation
- Social Service expertise on Homelessness issue but less-so on Housing issues

## WHERE DID WE START?

- Ensured involvement of all local municipalities
- Municipal Planners group
- Invited community agencies to a general meeting in January 2012

Sector Specific Meetings	<ul> <li>Seniors, Youth, Non-Profit Housing Providers</li> </ul>
Final Community Meetings	<ul> <li>Held 2 community meetings in order to review draft Strategic Objectives and Recommended Actions with interested parties</li> </ul>





- Knew this would be our biggest challenge
- Lack of local data
- Historically CMHC hasn't set Average Market
   Rent in Lanark due to small sample size
- Vacancy rates not available
- Split into 2 LHIN's, Champlain and South East
- Limited strategic planning documents to refer to

## **COMMUNITY MEETINGS**

- Advertised to public at municipal expense
- Majority of attendees were representing their organization
- Difficult targeting the "working poor"
- Held some sector specific meetings with groups that lacked representation at public meetings
- Attempt to be inclusive

"The time is ripe to develop a brand new way of thinking about housing for needy groups / individuals; I believe Lanark County and surrounding communities have the potential to become leaders and national examples for creative housing solutions – ideas such as developing mixed use, multi-purpose residence which offer clients hope, and the opportunity to move from subsidized rental space to some form of home ownership would do wonders for personal and local pride." 


#### CHALLENGES

- Incorporating the groups not represented discussions tended to be skewed depending upon who was at the table
- Local municipal involvement official plans, housing development
- Measurement high level plan
- Time restriction
- Separated town of Smiths Falls data and resources
- Limited budget
- Regular updates to plan loss of long form census
